**Terms & Conditions:**

- 1) The Appointment as Chairman of PLA is for a period of 5 years from the date they report to the duty or till the age of 65 years, whichever is earlier. He is not eligible for re-appointment.
- 2) The said officer is entitled for a monthly fees of last drawn salary less the amount of pension received by him. For the purpose of attending the sittings of Permanent Lok Adalat the Chairman is entitled for conveyance allowance of ₹. 5,000/- p.m.
- 3) He is not entitled for any other allowances, benefits etc.
- 4) He shall have to give an declaration that he does not and will not have any such financial or other interest as is likely to affect prejudicially his functions as Chairman of PLA.
- 5) He is eligible for 15 days causal leave in a year with prior sanction and not eligible for any other kind of leave.
- 6) He/she shall adhere to the office timings of the Permanent Lok Adalat i.e., 10.00 a.m. to 5.30 p.m. and to bestow his attention towards maintenance of registers, files etc., and also work towards popularizing the movement of Permanent Lok Adalat in the State.
- 7) The provisions under the Legal Services Authorities, Act, 1987 and the Permanent Lok Adalat (Other Terms & Conditions of appointment of Chairman and other persons) Rules 2003 as amended up to date are applicable as terms & conditions of the appointment.
