NOTIFICATION

In exercise of the powers conferred by Section 70 of the Karnataka Court Fee and Suits Valuation Act, 1958 (Act No. XVI of 1958). The Government of Karnataka hereby exempts payment of Court Fee payable by the persons entitled for free Legal Aid Services under Section 12 of the Legal Services Authorities Act, 1987 read with Regulation 31 and 32 of the Karnataka State Legal Services Authority Regulations 1997 or under any proceedings including suits, appeals etc., initiated before any Court or Tribunal, subject to issuance of "Court-fees exemption certificate" by Member Secretary of District Legal Services Authority /Taluka Legal Services Committee or Secretary of High Court Legal Services Committee as the case may be and directs that where the said person succeeds in the proceedings, the amount of Court fees, which would have been paid by him if such fee is not remitted shall be determined by the Court and amount, so determined shall be recoverable by the State Government from the party ordered by the Court in the decree to pay the same.
