Terms and Conditions:

- 1) As appointment of Member of PLA is being made in the middle of term and out of waiting list, he will be holding the post till 24.11.2022 (on which date he attains age of 65 years).
- 2) He is entitled for a sitting fee of Rs.2,000/- per sitting, as provided under the Permanent Lok Adalat (Other Terms and Conditions of Appointment of Chairman and other persons) Amendment Rules, 2003 and amendments.



3) As per Rule 7(3), the Chairman has to convene a sitting of Permanent Lok Adalat as and when necessary. Only when Permanent Lok Adalat is convened by the chairman for transacting the business, that day is called as 'sitting day'.

4) He is entitled for a Conveyance allowance of Rs.5,000/- p.m. as provided under the Permanent Lok Adalat (Other Terms and Conditions of Appointment of Chairman and other persons) Amendment Rules, 2003 and amendments.

4) He is entitled for such travelling and daily allowances on official tour as are admissible to Group "A" officers of the Central Government only with the prior approval from KSLSA.

5) He shall have to give a declaration that he does not and will not have any financial or other interest as is likely to affect prejudicially his functions as Member of PLA.

6) He shall adhere to the office timings of the Permanent Lok Adalat i.e., between 10.00 a.m and 5.30 p.m, and to bestow his attention towards maintenance of registers, files etc., and also work towards popularizing the movement of Permanent Lok Adalat in the State.

7) The provisions under the Legal Services Authorities Act 1987 and the Permanent Lok Adalat (Other Terms and Conditions of appointment of Chairman and other persons) Rules 2003 as amended up to date are applicable as terms and conditions of the appointment.




8) He shall have to conduct sittings at any Permanent Lok Adalats as per directions of the Hon'ble Executive Chairman, Karnataka State Legal Services Authority, as and when required

9) As directed, the nominated Member of the PLA who are practicing as on date as an Advocate at the respective place of his posting now as Member of PLA shall file undertaking before Karnataka State Legal Services Authority to the effect that he will not practice as an Advocate during his tenure as Member of the PLA in question.

10) When the Chairman of PLA is unable to discharge his functions owing to absence, illness or any other cause, the senior most (in order of appointment) Member of Permanent Lok Adalat holding, office for the time being, shall discharge the functions of the Chairman until the day on which the Chairman resumes charge of his functions.
