NOTIFICATION

In exercise of powers under Section 22B of the Legal Services Authorities Act of 1987 (Legal Services Authorities (Amendment) Act 2002 Karnataka State Legal Services Authority has established 6 Permanent Lok Adalats in respect of Public Utility Services mentioned in Karnataka State Legal Services Authority Notification No.1/PLA/42/ADM/01/2007, dated:29.01.2007. Further as per Notification of Government of Karnataka No.LAW 01 LAD 2008, dated: 13.03.2008, Banking and Financial institutions and also as per Gazette Notification issued by Ministry of Law and Justice, New Delhi, dated:16.02.2016 Education or Educational Institutions and Housing and Real Estate Services were added to Public Utility Services.

As per Gazette Notification issued by Government of Karnataka No. RD.27.BHADAPU /2006, dated: 27.06.2007 Ramanagara District was newly formed in the limits of Bengaluru Rural District and Chickkabalapur District were formed in the limits of Kolar District and also as per Notification issued by Government of Karnataka No. RD59.BHUDAPU 2008, dated:26.12.2009 Yadgir district was newly formed in the limits of Kalaburgi District

PLAs were established in 6 Districts. Newly formed Districts have to be brought under the Jurisdiction of a particular District where PLAs are established. Therefore, newly formed districts are included under the Jurisdiction of the PLA as specified in the schedule of this Notification.
