The Respondents-1 to 3 shall pay, jointly and severally, a sum of <b>Rs.8,68,369/-</b> with interest at <b>Rs.9.5%</b> p.a., (floating rate as per RBI directions) at monthly rests from 18.01.2021 in full and final settlement of the Petition claim.</p> <p>2. The Award amount shall be payable in monthly installments of <b>Rs.20,000/-</b> each with double default clause on or before 20<sup>th</sup> of every month.</p>
